02/10.02	Active/Inactive Handicaps Clarification with Reference to commencement date and Competition Winners eligibility to win if playing with an Inactive handicap.	Only those OPGCMA competitions where the competition rules require the 3 in 12 eligibility qualification will run on the rolling 12 months. These are usually our Majors and Knock-outs. All other OPGCMA competitions such as the monthly medals and stablefords will have no such restriction applied. If we were to apply the 3 in 12 eligibility rule to these competitions then new members would never be able to qualify for the Majors etc. or achieve an active handicap.
